VOLUNTARY SURRENDER AGREEMENT

THIS VOLUNTARY SURRENDER AGREEMENT dated \(\frac{1\2\2\2\2\2}{2\colon^2\3}\), is entered into between the borrower, MONISHA CHARMAINE MAZE (referred to below as "I"), and FIRST GUARANTY BANK (referred to below as "Lender").

VEHICLE DESCRIPTION: The word "Vehicle" as used in this Agreement means the following described property in which Lender has a security interest for the payment of the indebtedness and performance of all other obligations under the Note:

2020 GMC SIERRA 1500 (VIN: 3GTU9CED7LG443590)

LOAN DESCRIPTION: The words "Loan" and "Note" interchangeably refer to the promissory note dated October 13, 2020, in the principal amount of \$48,708.32 executed by MONISHA CHARMAINE MAZE in favor of Lender.

VOLUNTARY SURRENDER OF VEHICLE: Considering that I am in DEFAULT on the Loan and am unable to pay the balance due in the amount of \$41,300.98 on the Loan for which the above-described Vehicle is named as security interest, realizing that the vehicle will continue to decline in value, and in order that I may benefit from its maximum obtainable value, I hereby voluntarily surrender possession of the above-described Vehicle to Lender for such Disposition as Lender may choose, by depositing the Vehicle, both sets of keys, and the Certificate of Title (should it be in my possession) to Lender at the following location:

LIMITED POWER OF ATTORNEY: I hereby authorize and empower Lender as my attorney in fact to cancel any insurance on said Vehicle and to apply any premium refund to the Loan, and to execute in my name the Certificate of Title and any other documents to effect disposition, registration, transfer of title, and application for title.

REPRESENTATIONS OF BORROWER: I have not previously transferred or encumbered any right, title, or interest which I may have in the Vehicle, and I further acknowledge that I have carefully checked that the Vehicle is free of all my personal property.

DISPOSITION: The word "Disposition" means a public or private sale or lease or license of the Vehicle.

APPLICATION OF PROCEEDS OF DISPOSITION: I understand that the proceeds of the Disposition will be applied: first, to Lender's expenses associated with retaking, holding, and preparing the Vehicle for disposition, including all costs of Disposition and reasonable attorney's fees and legal expenses incurred by Lender since the Note was referred to an attorney for collection; second, to the satisfaction of the Loan; third, to the satisfaction of any obligations secured by a subordinate security interest on the Vehicle, should such exist; and fourth, to any secured party that is a consignor of the Vehicle.

SURPLUS OR DEFICIENCY: I hereby acknowledge and agree that, after the payments and applications required in the preceding paragraph have been made, I shall be entitled to any surplus proceeds, and shall be liable for any deficiency should the proceeds of the disposition not satisfy the total indebtedness.

WAIVERS: I hereby waive the right to notification of disposition of collateral under La. R.S. 10:9-611 et seq., and the right to require disposition of collateral under La. R.S. 10:9-620(e).
