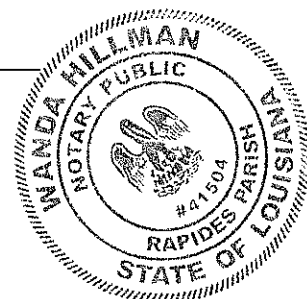

- **Owner Information**  
1) Always carry the attached registration card on vessel when in use.  
2) Stop and render aid or assistance if involved in a boating accident.
- **If the Certificate or Decals are Lost or Destroyed**  
Owner must submit an application and appropriate duplicate certificate fee to Department of Wildlife and Fisheries. In the case of lost or destroyed decals, owner must submit an application for duplicate certificate and decals along with notarized affidavit on reverse side. A copy of the application will be honored as a temporary certificate for a period not to exceed 30 days.
- **If a Change of Ownership or Address Occur**  
The owner/seller of a boat is required by law to report changes of ownership or change of address to Department of Wildlife & Fisheries within 15 days of the occurrence.
- **If Loss, Destruction or Abandonment of Motorboat Occurs**  
Owner must surrender to Department of Wildlife and Fisheries certificate of number along with a signed statement giving the date of destruction or abandonment within 15 days.
- **If the Motorboat is Stolen**  
The owner of a boat is required to report any registered boat, which has been stolen, to the Department of Wildlife and Fisheries within 5 days of discovering the theft.
- **Report Boating Accidents**  
The operator of a vessel involved in a collision, crash, or other casualty involving a recreational vessel and resulting in death or injury to a person or property damage in excess of \$500 must give notice of the incident immediately, by the most prompt means of communication, to the Department of Wildlife and Fisheries, at 225-765-2441 or [www.wlf.louisiana.gov](http://www.wlf.louisiana.gov) or in writing to Attn: Boating Accidents, P.O. Box 98000, Baton Rouge, Louisiana 70898. To obtain forms for reporting a boating accident, contact the nearest Wildlife & Fisheries office

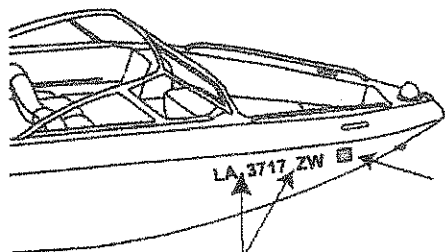
