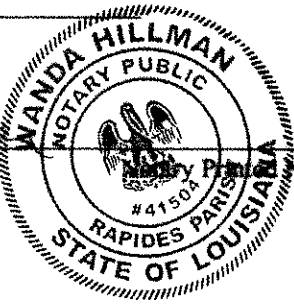

MOUNTING INSTRUCTIONS

DEALER MUST SUBMIT IN WRITING THE NAME AND ADDRESS OF PRIOR OWNER, THE REGISTRATION NUMBER SHOWN ON THE CERTIFICATE AND DATE OF PURCHASE OR TRADE WITHIN 15 DAYS UNLESS MOTORBOAT IS RE-ASSIGNED WITHIN THIS PERIOD OF TIME. NEW OWNER MUST FOLLOW SAME PROCEDURE OUTLINED IN (1-A) WITHIN 15 DAYS FROM THE RE-ASSIGNMENT DATE.

(2) LOST OR DESTROYED CERTIFICATE

** OWNER MUST SUBMIT A SIGNED STATEMENT GIVING THE DATE OF LOSS AND THE CIRCUMSTANCES WHICH CAUSED THE LOSS ALONG WITH AN APPLICATION AND DUPLICATE CERTIFICATE FEE WITHIN 15 DAYS AFTER LOSS. (4) THEFT OF MOTORBOAT

OWNER MUST REPORT TO THE DEPARTMENT OF WILDLIFE AND FISHERIES ANY REGISTERED BOAT WHICH HAS BEEN STOLEN WITHIN 5 DAYS OF DISCOVERING THE THEFT.

(5) BOATING ACCIDENT REPORT

A) LOSS OF LIFE-REPORT REQUIRED WITHIN 48 HOURS
B) PROPERTY DAMAGE IN EXCESS OF \$200 OR INJURY REPORT REQUIRED WITHIN 5 DAYS.

(6) PENALTY

ANY PERSON WHO VIOLATES ANY OF THESE PROVISIONS OR PROVIDES ANY FALSE INFORMATION SHALL BE SUBJECT TO CRIMINAL PROSECUTION.
